WEST WYOMING BOROUGH COUNCIL RESOLUTION NO. 7-2008

A RESOLUTION OF THE BOROUGH OF WEST WYOMING, COUNTY OF LUZERNE, COMMONWEALTH OF PENNSYLVANIA APPROVING TRANSFER OF CLUB LIQUOR LICENSE , LICENSE NO.C-5104 INTO WEST WYOMING BOROUGH FROM WYOMING BOROUGH

WHEREAS, Act 141 of 2000, the Act which amends the Commonwealth's Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code, if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the receiving municipality, West Wyoming Borough issues a resolution approving the transfer of the license outside the municipality, Wyoming Borough to inside the municipality of West Wyoming Borough; and

WHEREAS, amendments to the Liquor Code stipulates that, prior to adoption of a resolution by West Wyoming Borough, the receiving municipality, at least one hearing be held for the purpose of permitting interested parties to state their concerns regarding the transfer of a club liquor license in to West Wyoming Borough , the receiving municipality; and

WHEREAS, an application of transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a club liquor license into West Wyoming Borough.

NOW, THEREFORE, BE IT RESOLVED, the Wyoming Aerie 1965 Fraternal Order of Eagles has requested the approval of the West Wyoming Borough Council for the proposed transfer of their Pennsylvania club liquor license, License Number C-5104 to its facilities located at 445 W. Eighth Street within West Wyoming Borough which will trade as the "Eagles Club" with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that the West Wyoming Council finds that, the transfer of a club liquor license into West Wyoming Borough by the Wyoming Aerie 1965 Fraternal Order of Eagles will not adversely affect the welfare, health, peace and morals of the municipality of its residents.

BE IT FURTHER RESOLVED, that West Wyoming Borough approves, by adoption of this Resolution, the proposed transfer of Wyoming Aerie 1965 Fraternal Order of Eagles, License # C-5104 to be located at 445 West Eighth Street, West Wyoming , PA 18644 .

BE IT FURTHER RESOLVED, that the license transfer is subject to approval by the Pennsylvania Liquor Control Board.
